

**DONATE BY 4/15/18**  
or earlier, Dec. 31, 2017, for a federal deduction

**The White Mountain Tuition Support Foundation** (WMTSF) is an independent, non-profit School Tuition Organization (STO) created in 2000 to accept tax credit donations for private school scholarships (A.R.S. Section 43-1089). You still have two tax credits to take advantage of for 2017-18 and your limits are slightly higher this year!

**1. Original Individual Tax Credit** - This law allows individual taxpayers to donate up to \$546 (single taxpayer) or \$1,092 (married, filing jointly) to an STO like WMTSF and receive a DOLLAR FOR DOLLAR state income TAX CREDIT.

**2. The "PLUS" tax credit!** Enacted in early 2012, this law allows individual taxpayers to donate an ADDITIONAL \$543 (single) or \$1,085 (married, filing jointly) to help financially qualified students.

So, married filers can give up to **\$2,177.**

Individual tax payers can take the credits for up to **\$1,089!**

*(By law, a donor must first donate the maximum Original Individual Tax Credit before he/she can claim the PLUS Tax Credit. However, you may send just one check for both.)*

**Just follow these steps:**

- 1. Look for the line titled "Balance of Tax" on your state tax return** to see if you have a tax liability for 2017. This is the amount you can REDIRECT to St. Anthony's students by sending your tax credit donation to WMTSF.
- 2. You can write just one check** for both your original and plus credits. Or you can charge or debit them by calling 928-521-3826.
- 3. That's all there is to it.** Please complete the form to the right and send it in with your payment or call 928-521-3826. WMTSF will send you a receipt. Thank you for deciding how your tax dollars are spent!

**NOTICE:** A school tuition organization cannot award, restrict or reserve scholarships solely on the basis of donor recommendations. A taxpayer may not claim a tax credit if the taxpayer agrees to swap donations with another taxpayer to benefit either taxpayer's own dependent.
